The Fraternity and Sorority Life office is committed to advising and coaching our chapter leaders to effectively develop and manage their organizations as a member of our community. Grounded in Student Affairs' *Aspirations for Student Learning*, the Legacy Report is an annual document compiled by chapter officers to help them reflect on, and plan for, success in the following areas of chapter life:

- Values-Based Experience
- Recruitment/Intake
- Scholarship and Academics
- Risk Reduction/Risk Education
- Membership Development
- Community Involvement
- Recognition
- Assessment

In an effort to celebrate the success of our community and inspire our chapters to be their best version, the Fraternity and Sorority Community Report Card has been designed to reflect how well our organizations aspire to cultivate curiosity, self-understanding and integrity, civility, courageous leadership, and the spirit of *Ut Prosim* (That I May Serve), within chapter life. Indicators associated with the areas included above are based on evaluations completed by advisors for the Interfraternity Council (IFC), National Pan-Hellenic Council (NPHC), Panhellenic Council (PHC), and United Council of Fraternities and Sororities (UCFS). Each chapter president participates in a 1-1 coaching session with their council's advisor to review their chapter's Legacy Report and the assessment of their chapter's engagement within the community. Participation in the Legacy Report program is voluntary. If no report was submitted then this was indicated in the community report card. In those circumstances, a subjective evaluation of the chapter's experience was made based in our office's general knowledge of their operations.
